

Applicant in the capacity of being the Interim Resolution Professional (the "IRP") of the Corporate Debtor thereby seeking directions from this Hon'ble Tribunal, the Ld. Adjudicating Authority (the "LAA") for the appointment of the Authorized Representative (the "AR") of the Class of Creditors (Home Buyers) in accordance with the provisions of Section 21(6A)(b) of the Insolvency and Bankruptcy Code of

- India, 2016 (as amended) (the "Code") read with Regulation 16A(2) of the Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for Corporate Persons) Regulations, 2016 (as amended) (the "CIRP Regulations").
- That the LAA vide order dated 12th November, 2020 was pleased 2) to admit the captioned petition i.e. Company Petition (IB) No. 2488 (PB) of 2019 filed on behalf of the Financial Creditor i.e. Shri Debashish Majumdar against the Corporate Debtor i.e. M/s M-Tech Developers Private Limited for initiating the Corporate Insolvency Resolution Process (CIRP) under Section 7 read with Rule 4 of the Insolvency and Bankruptcy Code, 2016 (the Code). d)the recovery of any property by an owner or lessor where such property is occupied by or in the possession of the corporate debtor."

- 3) That in compliance of the orders passed by the LAA, the Applicant herein is conducting the CIRP of the Corporate Debtor in accordance with the duties, functions and powers enshrined in the Code.
